## **Website SMS Opt-In Information**

### ***Program Overview***

Bible Tabernacle Connect is the official text messaging communication system used by Bible Tabernacle of North Carolina. This system allows the church to communicate important ministry updates and to receive messages from members including prayer requests or church-related inquiries.

### ***Message Types***

Subscribers may receive messages related to church announcements, service reminders, event notifications, prayer request updates, ministry communications, and time-sensitive updates affecting church activities.

### ***Two-Way Messaging***

Members may text the church's designated phone number to submit messages to church administrators. Messages may include text, photos, or short videos. All messages received through the system are reviewed by authorized church administrators before being shared more broadly with other members.

### ***Opt-In Process***

Individuals may opt in to receive SMS communications through verbal consent during church services, membership discussions, ministry participation, or other in-person interactions where the SMS program is described and consent is requested.

### ***Message Frequency***

Message frequency varies depending on church announcements, ministry needs, and prayer notifications.

### ***Message and Data Rates***

Message and data rates may apply depending on your wireless carrier and service plan.

### ***Opt-Out Instructions***

Subscribers may opt out of receiving messages at any time by replying STOP to any message sent through the program.

# **Bible Tabernacle of North Carolina Text Messaging Program Terms and Conditions**

## ***1. Program Description***

Bible Tabernacle of North Carolina offers a voluntary SMS messaging program to provide church announcements, event reminders, service schedule updates, and other ministry-related information. By opting in, you consent to receive recurring automated text messages from Bible Tabernacle of North Carolina.

## ***2. Opt-In Consent***

By providing your mobile phone number and opting into the program, you confirm that you are the authorized user of the phone number, you consent to receive SMS messages from Bible Tabernacle of North Carolina, and you understand that consent is not a condition of membership or participation in any church activity.

## ***3. Message Frequency***

Message frequency varies based on church communications and ministry needs.

## ***4. Message and Data Rates***

Message and data rates may apply. Charges depend on your wireless carrier and mobile service plan. Bible Tabernacle of North Carolina is not responsible for carrier charges.

## ***5. Opt-Out***

You may opt out of the SMS messaging program at any time by replying STOP to any text message. After opting out, you will receive a confirmation message and will no longer receive SMS communications unless you re-subscribe.

## ***7. Supported Carriers***
